
CAUTION

 3. Please charge the headphones first if it has been left unused for a long time.
 4. The battery in the headphones is original and please do not attempt to
- change it yourself.
- **5.** Please keep the headphones in a dry place.
- **6.** Please keep away from temperatures in excess of 60 C to avoid battery blast accident.

OPERATION

Before using the headphones, you must charge the battery and pair the headphones with a compatible device.

CHARGING

The pack contains a Micro USB cable that can be connected to your computer or other device made for USB charging. Plug the Micro USB end of the included USB cable into the Micro USB port on the right ear cup of the headphones. Plug the other end into a USB port on your computer or other devices made for USB charging. The indicator light will be red while charging. Once fully charged, the indicator light will turn off. Charge time is 3 hours on an empty battery. The fully charged battery has power for up to 10 hours talk/music time (and up to 250 hours standby time).

Note: The headphones have a built-in lithium battery. Please fully charge for at least 4 hours before initial use.

BLUETOOTH ON

To switch on, press and hold the MFB for about 4-5 seconds. The blue LED indicator light is briefly displayed and a prompt tone is heard. The headphones will then go into pairing mode where the indicator light will flash Blue and Red quickly. When the headphones are connected to your device and are ready for use you will hear another prompt tone and the blue LED indicator flashes slowly while connected.

BLUETOOTH OFF

To switch off, press and hold the MFB for about 3 seconds. The red LED indicator light is briefly displayed and you will hear a prompt tone. If the headphones are not connected to a device within 5 minutes, they will switch off automatically.

OPERATION

PAIRING

 Ensure that your phone or Bluetooth enabled device is switched on.
 To pair the headphones if they have not been previously paired with a device, switch on the headphones and hold the MFB for 4-5 seconds until the red and blue lights flash.

3. Activate the Bluetooth function on your phone or Bluetooth device and set it

to search for available Bluetooth devices. **4.** Select "GV-BT1300" from the list of available devices on your phone or Bluetooth device.

5. When succesfully connected the blue LED indicator stays illuminated.

Note: If the headphones have been previously paired with another device they will automatically connect with the device if the devices power is on and within connecting range.

ADIUST THE VOLUME

To adjust the volume, press and hold the volume key up or down during a call or while listening to music. You will hear a prompt tone confirming you have reached minimum and maximum volume levels.

APPLICATION

GV-BT1300 can make and receive calls hands-free with your compatible mobile phone and listen to music from a compatible Bluetooth device, but they should be within 10 meters (33 feet) of each other.

CALLS

TO ANSWER A CALL Short press of the MFB

TO REJECT A CALL Long press of the MFB

TO END A CALL Short Press the MFB

VOICE ASSISTANT

Double click the MFB to activate Voice Assistant (This function is based on your mobile device supporting Siri, Google).

DISCONNECT THE HEADPHONES

To disconnect the headphones from your device, switch off the headphones, or disconnect it in Bluetooth menu of your device.

RECONNECT THE HEADPHONES

To connect the headphones to the phone or Bluetoth device that you have last used it with, switch on the headphones, or make the connection in the Bluetooth menu on vour device.

OPERATION

LISTEN TO MUSIC

To listen to music, connect the headphones to a phone or compatible Bluetooth device. The available music functions depends on your Bluetooth device. If you receive or make a call while listening to music, the music is paused until the call ends. To play a song, select a track on your music player and press the MFB on the headphones. To select the next song during playback, press the Next Track button quickly. To select previous track press the Previous Track button quickly.

PASSIVE MODE

You can use the GV-BT1300 as a wired headphone to save batteries. Connect one end of the included audio cable to the bottom of the right ear cup and the other end to your audio players 3.5mm jack.

Note: Inserting the audio cable disables the wireless functionality.

LOW BATTERY WARNING

You will hear a prompt tone every 20 seconds indicating the batteries are low and require recharging

LOW BATTERY POWER OFF

Your headphones will switch off automatically when the battery level reaches minimum.
