### **USB POWER**



### **LOADING A CD**

Press the **OPEN** button to open the **CD DOOR**.  
Load a CD into the player, label side up.  
Close the **CD DOOR**.

### **PLAYING A CD**

Press the **PLAY/PAUSE** button to begin playing the loaded CD.

### **Note: Electronic Skip Protection (ESP)**

Is a data buffer system so that audio will not skip while the disk could not be read due to movement, ESP being displayed signals that Electronic Skip Protection is active.

# PROGRAMMING A CD

1. Follow the instructions for loading a CD and Playing a CD.
2. Press the **STOP** button to stop the CD during play.
3. Press the **PROGRAM** button. "01" will begin to blink on the **DISPLAY**.
4. Press the **SKIP/SEARCH** buttons to select the track you wish to program.
5. Press the **PROGRAM** button to save the selected track you wish to program.
6. Repeat steps 4 and 5 to program up to 20 tracks to play in the order they are programmed. The number of programmed tracks shows on the **DISPLAY**.
7. Press the **PLAY/PAUSE** button to begin playing the programmed tracks.
